Decisions Subject to Review by the Tribunal (at 1 April 2025)

The Administrative Review Tribunal does not have a general power to review decisions. We can only review a decision if an Act, regulation or other legislative instrument states the Tribunal can review the decision.

We can review decisions made under more than 400 Commonwealth Acts and legislative instruments (**Table 1**). This document is for guidance purposes only and sets out the Acts, regulations and legislative instruments currently in force which state certain decisions may be reviewed by the Tribunal.

We can also review decisions made under a small number of Norfolk Island laws, including decisions about building, land valuation and planning (**Table 2**).

The list is arranged alphabetically and provides the following information:

- Column 1: The short title of the Act or legislative instrument.
- Column 2: The legislative provisions which provide the Tribunal jurisdiction to review a decision. Unless specified any provision specified is to the Act or instrument listed in column 1 for that entry
- Column 3: The legislative provisions under which a reviewable decision may be made, or a brief description of the reviewable decision.

Note 1: The legislative provisions listed in Column 3 should be consulted prior to being relied upon, as they may contain additional qualifications that impact upon the Tribunal's jurisdiction.

Note 2: References to a 'reconsideration decision' includes references to decisions made on internal review under the relevant enactment.

Note 3: This list includes those enactments which provide for advisory opinions. Advisory opinions are not decisions subject to review.
